**PROPOSAL:** Under this proposal CTG will provide new cameras at Employee parking lot and the entry archway, bldgs. D, V, A, C, W and Y.

#### New server

CTG will add 2 new Vicon servers to accommodate the cameras we are proposing for the employee parking lot, building D Commissary, Bldg. V, Bldg. A, Bldg. C, Bldg. W, bldg. Y. and site cameras. One server will be installed in the Rec building IDF 161A and the second one will be installed in Building A Equipment room.

#### Parking lot camera adds.

The current parking lot lights are switched from a photocell and lighting control panel in the storage building in the parking lot. To keep from cutting and trenching for new raceway to the cameras we will replace the camera heads, so the cameras are not switched. We offer the following.

Remove and replace (11) 25' parking lot pole lights with LED fixtures and built in photocells.

Remove and replace (6) 15' parking lot pole lights with LED fixtures and built in photocells.

Dispose of existing light fixtures.

Disable existing lighting controls so there is constant hot at each pole mounted POE.

8 new multi lens cameras will be added to give a full view of the parking lot with one view across the train tracks looking at the new Rec building. Install Etherwan wireless control boxes at each pole utilizing the switched power at the poles.

#### **GHS Entry Archway**

Add 2 cameras with license plate recognition at the GHS entry arch. Bring power from the pump control cabinet to power new wireless control boxes installed on the arch.

#### **Recreation Bldg. Adds**

4 receivers will be installed on the exterior of the Recreation building. 3 for the parking lot and 1 for the archway. These receivers will be run to IDF161A and plugged into existing CCTV switches. The head end for the Etherwan system will be installed in this room as well.

Add 13 new cameras to give site down product isles and in back rooms. Provide new raceway and cable for new cameras to the equipment rack in bldg. IT closet. Add cameras to existing network switch and Valerus VMS.

# **Building V**

Add 2 cameras to classroom V123. Provide conduit were necessary, and new cable. to the equipment rack in bldg. IT closet. Add cameras to existing network switch and Valerus VMS.

# **Building A**

Add one camera to replace existing exterior housing on SW corner of the building. Utilize existing raceway, pull new cable. Add cameras to existing network switch and Valerus VMS.

### **Building C**

Add one camera near the control room to get a better view in that area. Provide conduit were necessary, and new cable to the equipment rack. Add cameras to existing network switch and Valerus VMS.

### **Building W**

Provide 1 new exterior camera to view the sweat lodge on the east side of the building. There is an existing conduit roughly 5 feet from where the new camera will be installed. Provide one new camera on pole for camera 4 & 5 for view of the sweat lodge. Install cable to existing fiber box at the bottom of the pole. Add camera to Valerus VMS

Add 3 multi lens cameras to the exterior of the building on the NE, NW, and South sides of the building top give better views of the pathway around this building. Provide conduit were necessary, and new cable to the equipment rack. Add cameras to existing network switch and Valerus VMS.
