Child Care Health Consultants

There are currently about 250 nurses registered with DCYF across the state as Child Care Health Consultants Consultation (CCHC and formally called infant nurse consults). Garfield and Klickitat are the only counties where nurses haven't been identified. Through CCDF, a small amount of money has been allotted to begin on work on the creation of an online interface that is accessible by both nurses and child care providers, and should be completed in 2024. Until the systems is live, child care providers can get a referral for a local nurse by contacting Jennifer Helseth. Nurses who are interested in becoming a CCHC can also contact Jennifer for more information. The agency is experimenting with a pilot to use LPNs in addition to RNs to expand the workforce in communities where there is a nurse shortage. A training was created so that new nurses and child care providers can have a common understanding of what is expected from a CCHC. <u>https://www.dcyf.wa.gov/services/early-learning-providers/cchc</u>
