Rule Making Updates

Recently Completed Rules

Extended Foster Care Program

Washington State Department of Children, Youth, and Families (DCYF) filed <u>WSR # 25-10-016</u> to finalize rules for the Extended Foster Care (EFC) Program as required in Senate Bill 5908. The amendments will reduce systemic barriers by eliminating the federal eligibility requirements for youth who are dependent at the age of 18 and voluntarily enroll in the EFC program.

Rules Under Development

Placement of Juvenile Offenders Committed to the Juvenile Rehabilitation Division

The Washington State Department of Children, Youth, and Families (DCYF) Juvenile Rehabilitation Division (JRD) is updating the process to assign security classifications to youth in JR facilities. JRD will provide further clarity to current security classifications and add additional classifications as needed for increased safety and to reduce incidents.

The notice of intent for this rulemaking was filed under WSR 25-09-075.

Adoption Support Program

DCYF, Partnership, Prevention, and Services (PPS) Division is revising Chapter 110-80 WAC Adoption Support. These revisions will reflect federal law requirements which prohibits states from granting exceptional cost allowances to adoptive parents for child care costs as well as exceptional foster care rates. These revisions will also include general housekeeping edits and other updates to align with current practice. The notice of intent for this rulemaking was filed under WSR 25-11-001.

Proposed Rules

Licensing Standards for Kinship Caregivers

DCYF filed <u>WSR 25-09-153</u> to open the public comment period on proposed revisions to rules to amend chapter 110-147 WAC Licensing Requirements for Child Placing Agency and Adoption Services and chapter 110-50 WAC Child Welfare by adding references to the new chapter 110-149 Licensing Requirements for Kinship Homes WAC that takes effect July 1, 2025. That new chapter will provide licensing standards for kinship caregivers and will also provide greater stability and outcomes for children and youth placed in kinship care. This is a supplemental notice to <u>WSR 25-01-091</u>.

Recently Filed Rules

Board of Appeals Address Change

Department of Children, Youth, and Families (DCYF), Administrative Services Division is revising WAC 110-03-0585 Index of significant decisions. These revisions will update an address change for the BOA and include minor formatting changes, effective Monday, June 2, 2025. More information can be found in <u>WSR 25-10-105</u>.
