Inland Northwest Early Learning Alliance, Northeast

It's been a huge couple of months for our coalition! We are thrilled and relieved that WCFC was included in the final WA State budget at maintenance level funding! INWELA members have been working to name our priorities, finalize our regional budget, and put the finishing touches on our 2025-2026 Commitment Plan. We also recently named a new Fiscal Sponsor, Greater Spokane Inc. We are excited and ready for this next fiscal year!

Coordinated Recruitment and Enrollment efforts are ramping up with workgroups around Provider and Family Engagement, Communications, Data, Website Development, and more. The group's purpose is "to strengthen coordination between local public schools and early learning providers, ensuring equitable access to early education for all families. By addressing challenges in coordination, funding, and resource alignment, we can build a comprehensive and inclusive system that supports children, families, and providers. This effort will bring together industry leaders to shape regional education strategies, foster meaningful collaboration, and create lasting impact for Spokane's youngest learners. This work will not only enhance early learning access in Spokane but also serve as a scalable model that can be implemented in other communities across the region. Through dedicated collaboration and a shared commitment to change, we can build a stronger foundation for early learning that benefits families and providers well beyond Spokane."

Many INWELA members have been attending the local Social Connections Learning Series focused on the four Building Blocks of HOPE (Healthy Outcomes from Positive Experiences). The series wraps up in June and many of us are excited to continue our learning journey with the HOPE framework by participating in the HOPE Facilitator Training and subsequent community of practice spaces. We're excited by the positive impact this framework could have on our communities!

INWELA's Co-Lead, Colleen Condon, along with Excelsior Wellness and The Jasmin Group, is working to open an all-day, inclusive Child Care Center on the Excelsior campus in North Spokane!

NCELC members and leadership team supported local training events and opportunities that impact children and families: example: Symposiums offered by Our Valley Our Future. The Family Voice lead and NCELC Coordinator worked on a project with the North Central WA Library Children's Services Manager to inform families across North Central Washington about library services and resources and to add the information to NCELC web page.
