# *Updated* Early Support for Infant and Toddlers (ESIT) Program Vaccination Guidance

Gov. Jay Inslee's <u>Proclamation 21-14</u> requires state employees, health care workers, education staff, and most child care and early learning staff to **be fully vaccinated by Oct. 18, 2021, as a condition of employment**.

More recently, <u>President Biden announced his vaccine requirements for covered federal contractors and</u> <u>private employers with 100+ employees</u> in his <u>Path out of the Pandemic: COVID-19 Action Plan</u>. President Biden's announcement requires that all staff, regardless of position, working in agencies that receive Medicaid funding through the Centers for Medicare & Medicaid Services (CMS) be vaccinated. Since billing Medicaid and receiving payment for eligible services is an ESIT contract requirement, **this effectively means that all staff employed by an ESIT Provider Agency are required to be vaccinated against COVID-19**.

Being fully vaccinated is deemed a necessary prerequisite for the provision of in-person ESIT services by the state lead agency due to the high risk of working with potentially unvaccinated and vulnerable children and caregivers. This means that direct service providers who were granted a vaccination exemption and are eligible for reasonable accommodation must also be eligible for 100% tele-practice. If a position requires in-person service delivery, it is not eligible for accommodation.

With COVID-19 infection rates climbing and the prevalence of the more transmissible Delta variant, the safety of children and families receiving services, staff, and the provider community is paramount. As professionals in direct contact with children and families, we encourage you to continue to learn more about the science supporting the COVID-19 vaccine mandate. - All staff working for schools or ESDs receiving Medicaid funding through CMS
