He also works with other Casey partners, such as the courts, legislature, attorneys, other state agencies, foundations, and non-profits, to support system wide improvements through policy and practice changes. Ron has been a member of Casey Family Programs since 1995 and has provided leadership in various roles including direct services. Prior to Casey Family Programs, Ron worked for the State of Washington as a Community Services Office Administrator, Regional Administrator for the State's Division of Alcohol and Substance Abuse and was a direct practitioner for the Children's Administration. He has also worked in other private non-profit organizations. Ron's analytical thinking, problem-solving, listening, humor and ability to maintain self-control under pressure are attributes he is recognized for.
