Expanding Child Care Access During COVID-19

DCYF is implementing workforce supports in response to COVID-19. This effort is for licensed providers caring for children requesting additional staffing from the state's substitute pool.

The goal is to address COVID-19 impact on child care by:

- Providing substitutes and other connections for available and interested workers to meet the needs of licensed program staffing shortages or expanded capacity (wages subsidized by the state)
- Connect programs with eligible workers for recruitment support (wages not subsidized by the state)

A series of steps including process and WAC updates have been implemented in order to support child care providers who are serving families and essential workers in need of child care services during this pandemic.

Training Updates

Bill Passes for Community Based Training Pathway

The 2020 Legislative Session has ended and SHB 2556: Providing regulatory relief for early learning providers was signed on April 3 and will go into effect June 11, 2020.

This bill allows DCYF to develop a community based training as an equivalent pathway to meet the licensing education requirement for an initial and short certificate.

• What's Happening Now?

DCYF is working with our partners, including
Child Care Aware of Washington, Imagine
Institute, Washington Child Care Association, SEIU 925, Washington Family Child Care
Association and Washington State Board of Colleges and Technical Colleges to outline the
community based model and how it will be delivered.

• What Happens Next?

o This non-credit bearing option will be available Summer 2021.

How does the bill impact the timeline for education?

 DCYF will extend the timeline until August 1, 2026, for providers to complete the licensing requirement of an initial or short certificate.

DCYF Suspending In-Person Training

DCYF is suspending all in-person training between now and May 31, 2020.

Measures have been taken to comply with the Governor's <u>Stay Home, Stay Healthy order</u> as well as the social distancing guidance from the United States Centers for Disease Control and Prevention (CDC).

Increasing Access to Child Care Basics

DCYF is adapting the Child Care Basics (CCB) curriculum to be offered online through DCYF's online training portal. Some key points about this new option:

- Expected to roll-out in the summer of 2020 find options for registration in MERIT
- Available at no cost for providers
- Meets Federal training requirements
- Enhancements to content including an anti-bias mindset
