Dr. Marian Harris – Dr. Harris is currently serving as Co-Chair for the Racial Equity and Impact CRP. Dr. Marian S. Harris, PhD, LICSW, ACSW is the Diversity, Equity and Social Justice Program Officer at the Washington Association of Child Advocate Programs. Dr. Harris is Professor Emerita, University of Washington Tacoma, School of Social Work & Criminal Justice. She is nationally and internationally known for her work as a child welfare researcher/scholar; licensed clinical social worker; and advocate for children and social justice, and has received several teaching, research and practice awards throughout her career including the 2021 Social Justice Award from the WA State Society for Clinical Social Work. Dr. Harris is a prolific writer who has written books, journal articles, technical reports, training manuals, amicus briefs, op eds, newsletter articles, etc. One of her more notable books is *Racial Disproportionality in Child Welfare* (2014) published by Columbia University Press. Her most recent book is *Children of Incarcerated Parents: Silent Victims* (2023) published by Cambridge Scholars Publishing.

Shrounda Selivanoff – Shrounda Selivanoff is the Social Service Manager at the Washington State Office of Public Defense. She brings a fierce and passionate voice advocating for change to remove systemic barriers that impact children and families in child welfare. She was previously involved with the child welfare system and has since reunited with her daughter. Shrounda's child welfare experience birthed an advocate seeking to destigmatize parents and move towards engagement that sees and values parents as partners. Shrounda's work prioritizes marginalized and disenfranchised families and relentlessly pursues policy change and revolutionary changes toward preserving and strengthening families.

Keoki Kauanoe – Keoki is a native Hawaiian and single-father, the Facilitator of Father Engagement at Family Education and Support Services, Master Trainer for the Nurturing Fathers Program, Family Advocate and Community Organizer. Keoki serves on the Washington State Fatherhood Council, Board of Equity in Education Coalition, Thurston County DEI Council, and is the Chair of the Washington Democrats Asian and Pacific Islander Caucus. Keoki is a strong advocate for second changes, forgiveness, compassion, kindness, and mutual understanding.

Dr. Chereese Phillips – Chereese is presently the Senior Director in Research Services at Casey Family Programs. She has several years of experience designing, advising, and supporting child welfare research and evaluation projects at the local, state, and federal level. Most recently she was the Director of Data Driven Practice at Casey Family Programs. Previously, she served as a specialist at the Children's Bureau with a portfolio consisting of

contracts and grants which sought to build evidence in the child welfare and substance use disorders space.
