

Creating Shared Definitions:

- Indian Nations Agreement term used to acknowledge the delivery of an agreed upon set of services to the caregivers of children who fall under tribal jurisdiction.
- Contract refers to the provider/agency who enters into a contract to provide a set standard DCYF services to the caregivers of children who fall under DCYF jurisdiction and/or tribal jurisdiction children if the tribe chooses.
- Intergovernmental Agreement (IGA) means an Agreement acknowledging sovereignty between two governments (Indian Nation and State/DCYF) to deliver negotiated services agreed upon by both parties

Caregiver Supports - Phase 2 Overview

The Caregiver Supports Contracts will be awarded to providers through a bidding process.

The state will be divided into 14 catchment areas.

Implementations starts July 2024 with all catchment area contracts executed statewide in 2026.

Provide Placement Supports to both licensed and unlicensed caregivers.

Pre-authorized Case Aide hours will be part of the Placement Supports available for caregiver supports levels 3 through 7.

Options for Indian Nations

Enter into an Agreement with DCYF to receive reimbursement for Caregiver Supports provided to caregivers of tribal jurisdiction children.

Have Caregiver Supports provided by a catchment area contractor.

Opt-out of Caregiver Supports



Caregiver Supports - Support Services

Basic Support (level 1-3) plan would include the following support to caregivers:

- Assistance coordinating educational advocacy for school aged children.
- Assistance coordinating health and dental services.
- Assistance identifying and accessing childcare.
- Parenting skills providing as requested, resources and skills training to support the caregiver in safely and supportively parenting the children and youth in their care.
- Assistance in accessing/providing culturally relevant services to each child.
- Assistance with transition to adulthood planning/independent living skills.
- Assist with on-call support service that include 24/7 crisis phone support and coaching.

Enhanced Support (level 4-7) plan provide the following support to caregivers:

- All services provided through basic support level 1-3.
- Additional services assisting with crisis support services. This shall include, but not limited to:
- 24/7 crisis planning that includes after hours availability that include:
 - Phone coaching and assistance; and
 - In-person coaching, and assistance as needed.
- Assisting the caregiver to locate and schedule appropriate respite care for each youth.
- Assistance with creating and implementing support plans as necessary for youth and caregivers.
- Assistance with coordinating case aide supports as needed.

Options – For Serving Indian Nation Dependent Youth

We will describe 3 options for Indian Nations providing and being reimbursed for services provided under an agreement on the next slides.

Option #1: Caregiver Support Rate is a level 2 payment for all Indian Nation Children served under your agreement.

Option #2: Caregiver Support Rate is the median level for all Indian Nation Children served under your agreement.

Option #3: Caregiver Support Rate determined by each child's support level. (Caseload Ratios determined by use of caseload calculator)

Option #1 Level 2 payment for all Indian Nation children served under agreement.

Receive one payment rate for all Indian Nation dependent children served under this agreement.

• Payment would be Level 2 based on zone. (Slide #4)

This option does **not** require the use of variable Case Ratios that are required for Option #1.

1:25 Case Ratio

If a Tribe chooses this option, they need to provide basic caregiver support and basic emergent on-call support.

Will be able to access and bill for case aide services for youth level 3-7

• Will **not** need to provide enhanced caregiver support or enhanced emergent support.



Option #2: Median payment - for all Indian Nation Children served under agreement.

Receive one payment for all Indian Nation dependent youth served under this agreement.

• Payment would be a median payment of \$673 per child served.

This option does **not** require the use of variable Case Ratios that are required for Option #1.

1:25 Case Ratio

If a Tribe chooses this option, they need to provide basic *and* partial enhanced caregiver support.

Will be able to access and bill for case aide services for youth level 3-

In-person crisis response optional



Option #3: Caregiver Support Rate determined by each child's support level.

In the new agreement there are caseload standards implemented to support the higher rates.

This option requires the use of Case Ratios.

If a Tribe chooses this option, they need to provide basic and enhanced caregiver support and emergent on-call support.

Will be able to access and bill for case aide services for youth level 3-7

Caseload calculator: A tool to help manage a caseload of a variety of different levels. Shows the hours left over that can be billed for case aide. *See link below*.

Caseloads ratios are factored in as part of the Caregiver Support Rate on Slide # 4.



Considerations: Need for Caregiver Support Level Determination (Rate Assessment) and Open TPO Case

All Tribes have the option to complete their own Caregiver Support level determinations (rate assessments) for their TPO children or to have DCYF complete the determinations

- As part of Phase I, Tribes made this decision related to their TPO children in all *licensed* homes, for which a level determination is required for foster care reimbursement
- Some options in the Indian Nations Caregiver Supports Contract require level determination for all unlicensed homes in addition to licensed homes which will be an additional workload to consider

For Caregiver Supports to be provided, there needs to be an open TPO case.

Tribe opts out of Caregiver Supports

Contract services

 No need to complete level determination for unlicensed homes or open TPO cases.

Tribe has Caregiver Supports provided by Catchment Area Provider

• Tribe or DCYF must complete level determinations for licensed and unlicensed homes and open TPO cases for all youth receiving services.

Tribe enters
into Caregiver
Supports Agreement
with DCYF

- AND Tribe chooses Option 1, 2, or 3: Tribe or DCYF must complete level determinations for licensed and unlicensed homes to determine the appropriate level of caregiver supports.
- Open TPO cases for all youth receiving services.



Case Aide Authorization – Automatically Authorized based on Level

All options can utilize and bill for case aide hours, based on the table, without prior authorization.

Travel time and mileage is paid, in addition to the pre-authorized hours. (Pre-authorized hours + travel time = total hours billed)

Options for Indian Nation Agreement

Tribes can choose one type of case aide.

Behavioral Case Aide Rate - \$55.78 to 62.68 per/hour

- Additional Requirements
- 21 Years Old
- 24 months experience or 12 months and 1 hr of supervision per 40 hours worked.

Standard Case Aide Rate - \$30.00/hour

Caregiver Supports Contract for DCYF Caregivers

If Tribes choose not to enter into their own Caregiver Supports Indian Nation Agreement, they will have the option to have their members served by the catchment provider who is awarded the contract for their area, or to opt out of caregiver supports all together, (see slide 14 for updates on contract development).

- Placement Supports will not be available statewide all at once, they will rollout on a schedule by catchment area starting in July 2024 with the final contracts being executed in mid 2026.
 - See next (16) slide for rollout schedule for the first procurement, catchment areas 1-8, and slide 17 for second procurement schedule, catchment areas 9-14
- Tribal Agreement implementation will mirror catchment area implementation.
- Tribal decisions on how or if they want Caregiver Supports provided to their children and families should be received 30 days prior to the "Award Date" listed on the next two slides.
 - For the first two catchment areas this does not apply.
- The rollout order of catchment areas was determined by the following:
 - Areas with higher placement instability
 - Areas with higher percentage of kinship placements
 - Provider / Service capacity

Updates on Caregiver Supports Contract Solicitation for Catchment Area Providers

- Tribes have been invited to participate in the general contract procurement via 'Dear Tribal Leader'
 letter. Four Tribes expressed interest in becoming panel participants; two of those four Tribes
 committed to participating and, one Tribal representative participated in the contractor selection
 process.
- There were 6 applications received from potential contractors to serve 8 catchment areas (identified on slide 15)
- March 7th, 8th, and 11th Caregiver Supports panelists assembled which included internal DCYF staff, caregivers, external partners, and Tribal partners to review each service provider's application.
- March 19th Date by which area service providers will be notified of the panel's decision to award catchment area Caregiver Supports contracts for DCYF caregivers.

Further Considerations

Caregiver support service providers and Tribe's will be offered additional reimbursement for the initial 3 months to support start-up and ramp-up costs.

- Month 1 costs to support Director, Program Manager, and associated modeled costs (see slide 24 for full fee table).
- Month 2 continued reimbursement to support month 1 positions and create policy, procedures, and associated modeled costs.
- Month 3 continued reimbursement to support month 1 and 2 positions in addition to 1/3 of maximum FTE authorized Placement Support Managers as modeled in the fee table.

This information will be outlined in the draft Agreement.



When can Tribes begin Caregiver Supports Reimbursement?

- Caregiver Supports for the first two catchment areas servicing DCYF caregivers will begin July 1st, 2024.
- Indian Nations have the option to begin implementing Caregiver Support services as they roll out in the catchment area the Tribe is located in.
 - Increasing Indian Nation's workforce to meet agreement requirements are built into the agreement implementation (start-up/ramp-up).

Consideration for Tribes who conduct their own rate assessments:

- Some Caregiver Supports service options will require all Tribal Payment
 Only children in unlicensed/relative care to have a rate assessment in
 order to determine the support level provided to the Caregiver.
 - If Tribes choose to provide Caregiver Supports and choose Option #1 or if they choose to have the catchment area contractor provide Caregiver Supports, rate assessments will be required on all children in unlicensed placements.

Discussion and Questions

DCYF will work diligently with Tribes to obtain a decision from each Tribe on how/if they would like Caregiver Supports implemented.

Tribes have the option of:

- Entering into an Indian Nations Caregiver Supports Agreement to serve their own tribal jurisdiction caregivers
- Using a contracted provider in their catchment area to serve their tribal jurisdiction caregivers
- Opting out of Caregiver Supports and continue serving their members as they always have

Considerations for Tribes with lands in multiple catchment areas:

• If a Tribe has lands located in different catchment areas and they choose not to enter into their own Caregiver Supports Agreement, the Tribe may be working with multiple contracted providers serving each catchment area.



Request for Tribal Guidance

How would Tribes like to proceed?

• Please provide your Tribe's caregiver supports services decision prior to your Tribe's catchment area roll out on slide 17 (first area will go live July 1^{st} !)

Tribal Options:

- Entering into an Indian Nations Caregiver Supports Agreement
- Using a contracted provider in your catchment area
- Opting out of Caregiver Supports and continue serving their members as they always have

If a Tribe does not provide guidance on the above 3 options by their catchment roll-out date:

- DCYF will not refer your Tribal caregivers to the catchment area provider, for Caregiver Supports services.
- Your unlicensed caregivers **will not** receive Caregiver Supports until your Tribe provides a response as to the options.
- Tribes can make the decision as to the above options at any time before or after their catchment area rollout.
