

DCYF Child Care Complex Needs Fund Scoring Rubric

The purpose of the Scoring Rubric is to help providers and those scoring the grants understand the level of information that DCYF expects to see in the grant application. Applicant responses will be scored based on the rubric below. Each spend category has three scored questions (A, B, C). Each are worth up to five points. Scores for each spend category will be totaled (up to 15 points).

Providers who request funds in multiple categories will have their category totals averaged and will receive one score. For example, if a provider applies for funds in adding staff members, facility improvement, and therapeutic services and scores 9, 15, and 3, the provider's total average score will be 9. Providers applying for funding in multiple areas will not be prioritized over providers applying for funding in one area.

Providers in extreme access child care deserts* will receive 5 bonus points to their total score. Providers serving or located in marginalized, low-income communities* will receive 5 bonus points to their total score.

Providers must have an average score of 9 or higher (before bonus points) for their application to move forward to the prioritization phase.

This rubric serves as a tool to help sort through grant applications, but is only one factor in determining how grant funds will be distributed. DCYF will gather data after all applications have been received, and use that data to determine how to best fund applications.
