### Diaper Payment Benefit for TANF/SFA households

- Starting November 1, 2023
- Community Service Division (CSD) will automatically issue \$100 each month
  - to TANF/SFA households with an eligible child under 3 years old
  - to support child-related necessities such as diapers, pull-ups, and wipes
- Made possible by <u>SB 5838</u> (passed in 2022 session) and <u>ESSB 5187</u> (passed in 2023 session)
- Please contact your local CSO with eligibility or other questions

#### **FY24 Contract Amendments**

- HVBAT
- Rescue/Concrete Goods
- Timeline Aiming to start early November

#### MIECHV / HVBAT

#### for those programs with HVBAT in your FY24 contract

- We are <u>NOT</u> asking for HVBAT this year, even if it's in your current contract
- Upcoming Contract Amendments will
  - remove HVBAT language in the SOW
  - Remove the HVBAT \$5000 incentive
  - [internal: Reallocate unspent MIECHV FFY21 to MIECHV FFY22]

#### Rescue Updates to FY24 Contracts

- Amendments will add
  - Language in SOW to support "rescue" work
  - Rescue funds (MIECHV and State) will be added to budgets
  - To Be Determined: If/How much for Workforce Incentives
- Dollars will be distributed according to your current contract # slots (by state funding combined & MIECHV)
- May include some combination of concrete supports and workforce incentives
