

- On-time invoicing: reminder monthly invoices are <u>due</u> by the 30th of each month.

Rescue Spend – Program Sharing (Topics)

Rescue Spend – Program Sharing: Assessing Need

- Surveys: sent to families or completed with families during visits
- Informally ask families via text, home visit, phone call monthly



Rescue Spend – Program Sharing: Planning for FY23

- Based on reported family need gift cards, PPE, diaper supplies, technology
- Planned distribution: monthly, every other month, or quarterly distribution of gift cards, PPE, diaper supplies to all families
 - Same amount gift card to all families
 - Varying amounts based on reported need (survey): higher amounts for higher need
 - Everyone gets gas + food gift cards
- Technology as needed
 - Minute/data phone cards distributed monthly to the families with identified need



Rescue Spend – Program Sharing: Concrete goods *distributed to families*

- Gift cards: gas & food
- Diapering supplies: either by LIA or diaper bank
- PPE: thermometers, masks, hand sanitizer, sanitizing wipes
- Minute/data phone cards
- Tablets with 12 month data subscription
- Hotspots with 12 month subscription for services

HV-BAT communication from HRSA

- This morning, we received communication that our HV-BAT may be submitted this year in its current form *or* next year after HRSA revises the process based on feedback from Cohort 1
- We are considering moving forward with submission this fiscal year for the following reasons:
 - Availability of incentives this year (no guarantee next year)
 - Honor (and compensate) the efforts already committed to this project
 - Hope that the data will support the home visiting cost study underway this year
