## Rehabilitation Administration/ Juvenile Rehabilitation Prison Rape Elimination Act (PREA) 2017 Annual Data and Compliance Report

This document serves as an annual review to assess and improve the effectiveness of sexual abuse prevention, detection, and response policies, practices, and training in the Washington State Rehabilitation Administration/Juvenile Rehabilitation, specifically Juvenile Rehabilitation (JR), pursuant to §115.388 and §115.389 of the national PREA standards. Therein, JR is required to:

- 1. Review and aggregate incident-based sexual abuse data annually in order to improve the effectiveness of sexual abuse prevention, detection, and response policies, practices, and training to include:
  - a. Identifying problem areas
  - b. Taking corrective action on an on-going basis; and
  - c. Preparing an annual report of its findings
- 2. Compare the current year's data and corrective actions with those from prior year's and provide an assessment of the agency's progress in addressing sexual abuse.
- 3. Publish an annual report of its findings and corrective actions for each facility, as well as for the agency as a whole, on the JR public website.

#### **Aggregated Data**

Allegations of sexual abuse and sexual harassment are reported via electronic incident reports using JR's Automated Client Tracking system (ACT). ACT sexual abuse and sexual harassment data is collected from the following 12 locations:

#### Comparative Data Analysis of 2014, 2015 & 2016:

• **Youth-on-youth** *abusive sexual contact* allegations increased from 6 in 2014, 12 in 2015, and 6 in 2016. In 2014, all 6 allegations were substantiated; in 2015, 8 of the 12 allegations were substantiated; and in 2016, 1 of the 12 allegations was substantiated.

During the three-year period there was only 1 allegation of a *non-consensual sexual act* occurring in 2014; it was substantiated.

- Staff sexual misconduct allegations increased from 9 in 2014, 13 in 2015, and 14 in 2016. In 2014, 1 of the 9 allegations was substantiated; in 2015, 3 of the 13 allegations were substantiated; and in 2016, 5 of the 14 allegations were substantiated. During the three-year period both the number of allegations and the number of substantiated acts has increased.
- Facility type indicates that most allegations occur in JR's largest institutions, Green Hill School and Echo Glen Children's Center. However, all 3 of the 2015 substantiated acts of staff sexual misconduct occurred in community facilities. Conversely, 4 of the 5 substantiated acts of staff sexual misconduct in 2016 occurred in all 3 JR institutions (Naselle Youth Camp had 1).

#### 2016 Agency Actions

- Development and statewide delivery of three-hour staff refresher training, with a focus on proper reporting and detecting potential abuse through red flag behaviors.
- 3 facilities completed and passed federal PREA audits.

- Quarterly PREA compliance manager meetings focusing on lessons learned during facility audits throughout the year and evolving PREA interpretations.
- Several facilities either replaced or added video cameras to address blind spots.
- Information Technology enhancements enabling a broader range of data collection necessary for more detailed reporting of allegations and tracking.
- Completed internal PREA facility audits via DOJ certified auditor (JR employee).

JR is committed to maintaining zero tolerance facilities that provide safe, healthy, non-sexualized environments where residents are free from sexual abuse and sexual harassment. JR fulfills this commitment by constantly assessing policies, procedures, data, audits, and training and education.
