Department of Justice, <u>Office of Juvenile Justice and Delinquency Prevention's</u>

<u>Title II Formula Grants Program</u> supports state and local delinquency prevention and intervention efforts, and juvenile justice systems improvements.

Only state agencies (DCYF) designated by the Governor are invited to apply.

The State Advisory Group (WA-PCJJ) sets priorities for funded activities.

The DCYF Office of Juvenile Justice administers the funding through sub-grants.

 - January 31: Last day to pass bills out of committee and read them into record on the floor in house of origin (with some exceptions).
 - February 5: Last day to pass bills out of committee from House fiscal committees, Senate Ways & Means, and Transportation committee in house of origin.
 - February 13: Last day to pass bills in house of origin.
 - February 21: Last day to pass bills out of committee from opposite house.
 - February 26: Last day to pass bills out of fiscal committees from opposite house.
 - March 1: Last day to pass opposite house bills (with exceptions).
 - March 7: Last Day of Session

OJJDP Title II 3 Year Plan-Looking Back

- Current plan was drafted and submitted summer of 2021
- Covers 3 years of PCJJ funding priorities and activities:
 - October 2021-September 2022
 - October 2022-September 2023
 - October 2023-September 2024
- Title II Funding Awards are received Annually
- Funding awarded in 2021, 2022, and 2023 must be spent in alignment with the corresponding 3-year plan's priorities and objectives.



Objective 1: Alternatives to Incarceration

- Support the Law Enforcement Data Analysis Project.
- Explore the impact of COVID on detention admission decisions/policies.
- Build capacity for alternatives to arrest and detention.



Objective 2: Reduce recidivism and support youth transitioning out of the juvenile justice system

- Increase community-based connections and mentoring relationships for youth exiting state secure confinement.
- Build the inter-organizational infrastructure necessary for collaborative tracking and planning of sustainable re-entry.
- Support effective community-based intervention programs that address trauma, behavioral health and educational challenges and parental and caregiver support.
- Support a process where all youth transitioning from JR facilities will have access
 to effective services supported by mentors and credible messengers who reside
 in the youth's local community.

3 Year Plan Work Group Milestones

February Meeting

- Review the current Plan and any key points from Jan. 18th Full Council Mtg.
- Determine if any priorities/activities should be carried into the new Plan

March Meeting

- Review most recent WA State Juvenile Justice Data, current best practices and emerging research/trends
- Identify new priorities, if any, to add to the new Plan

April Meeting

- Identify measurable and attainable objectives supporting the identified priorities.
- Prepare recommendations to the Full Council for the New 3 Year Plan



Biennial Report to the Governor—Looking Back

- Drafted summer 2022, published November 2022
- Key Findings provided by WA State Center for Court Research
- Identified recommendations to the Governor and Legislature for improving Washington's juvenile justice system
- Data Book added 2019 and 2020 data trends
- Included updates on Council Funding, Grant Awards and Activities through 2021



Objective 1: Serve children at home, in their communities, with their families

- 1.1: Reduce out-of-home placements by supporting effective community-based alternatives to incarceration.
- 1.2: Implement policies that align with research regarding low-risk youth and limited system involvement.
- 1.3: Incentivize changes in policy and practice to continue downward trending of juvenile detention admissions.
- 1.4: Invest in infrastructure that promotes accountability, transparency, and system improvement.

Objective 2: Open opportunities for youth involved in the juvenile justice system

- 2.1: Reconsider how recidivism is defined and measured.
- 2.2: Support community partnerships for transition services.

- Review the Title II 3 Year Plan priority areas and objectives completed in April.
- Review Key Data Findings provided by WSCCR and identify recommendations informed by the data.

June Meeting
