

# Child Placing Agency & Tribal Child Placing Agency Contact List *For Kinship Licensing*

### Path Toward Licensure

As a kinship caregiver, you have the choice of getting licensed with the state or with a child placing agency (CPA). Getting licensed through a CPA/Tribal CPA can be a good choice if you want:

- Additional ongoing support in understanding and working with the foster care system
- To be licensed with an agency that reflects your culture and specializes in working with families like yours

# What is a Child Placing Agency?

A Child Placing Agency (CPA) is an agency licensed by DCYF to complete home studies and supervise children and youth placed in the care of the families licensed by the agency. These agencies share DCYF's goal to reunify families, and they can assist families when a different permanent plan like adoption is needed. Washington is home to many Child Placing Agencies! We encourage you to learn more about the agencies listed in this resource. Here is some quick guidance to get you started!

- 1. Review this list to learn more about the CPAs and Tribal CPAs that specialize in kinship licensing.
- 2. Contact them and ask questions about their services to help you figure out which is the best fit for you! Use the "list of things to consider" in this publication as a guide.

#### **State Licensing**

- Kinship caregivers work directly with local Licensing Division staff for licensing.
- Kinship caregivers self-advocate for specific needs, services, and resources.
- Services are coordinated by kinship caregiver and DCYF case worker.

# **CPA/Tribal CPA**

- Kinship caregivers work directly with local private agency staff for licensing.
- CPA/Tribal CPA provides advocacy for family and child needs, services, and resources.
- Services are provided or coordinated by the CPA/ Tribal CPA.
- Families receive individualized support from the CPA/ Tribal CPA.

DCYF's Licensing Division is the licensing authority, whether licensed directly by the State or certified by a CPA/Tribal CPA.

#### **All Families**

Foster families receive support from DCYF's contracted partners at the Alliance CaRES Program.

### Things to consider when looking at different CPAs/Tribal CPAs:

- Are you or the children/youth in your home enrolled in or connected to a tribe? Some tribes have their own CPAs and getting licensed by a tribal CPA may be an option for you.
- Where are you located? CPAs/Tribal CPAs generally only license families within a specific region. Look for agencies that license where you are located.
- Are you caring for a youth with higher behavioral needs? Some CPAs/Tribal CPAs specialize in providing therapeutic and behavioral supports.
- Are there specific values you are hoping to see reflected in an agency? CPAs/Tribal CPAs vary in terms of their values, religious affiliations, and the populations they have experience serving.
- Do you want to talk with current licensed caregivers to learn more? You can ask CPAs/Tribal CPAs to provide references.

Cultural experience and connection are big parts of fostering with PTCS, and it is a requirement for all Puyallup Tribal licensed foster homes. They have a dedicated team that is there for you 24/7 (after hours and for emergencies).
