



#### **Early Achievers Accreditation Policy**

What: Eligible participants receive an additional five points toward their final rating, as well as an Accreditation Area of Specialization on their rating certificate.

Who: All child care providers that are fully accredited by agencies that are formally recognized by the Early Achievers Accreditation Review Team. At this time, the agencies that are formally recognized are:

- National Association for the Education of Young Children (NAEYC)
- National Association for Family Child Care (NAFCC)
- American Montessori Society (AMS)
- National Accreditation Commission (NAC)
- AdvancED

When: Accreditation is considered at the time of Early Achievers data collection.

Why: The Early Achievers accreditation policy recognizes participating providers who have shown a commitment to quality through the accreditation process.

**How:** Eligible participants will receive five accreditation points toward their rating, as well as an Accreditation Area of Specialization on their Early Achievers Certificate. In order to earn accreditation points, providers must:

- Present a current certificate or other documentation during data collection that states the facility is fully accredited by an agency that meets the Early Achievers accreditation requirements.
- Document current accreditation on the IRRT, including the location of their current certificate of accreditation for verification by the data collector.
- Participate in full data collection and meet the minimum score requirements in ERS and CLASS.

#### **Frequently Asked Questions**

#### My accredited facility has already been rated. Am I still eligible for the accreditation points?

Programs that are accredited by agencies recognized by the Department of Children, Youth, and Families will be eligible for accreditation points and recognition on their next re-rating or renewal rating. The accreditation policy is not retroactive. However, participating rated providers may apply for the Accreditation Area of Specialization, which is a certificate of recognition that will be mailed to qualifying facilities. ### My facility's accreditation program is not on your list of recognized agencies. Will this policy apply to me?

At this time, NAEYC, NAFCC, NAC, AMS and AdvancED have met the Early Achievers criteria for accrediting programs. The application process is open to all accreditation agencies. Please contact your accreditation agency to see if they have begun the Early Achievers Application for Accreditation Agency Recognition.

## I am an AMS-accredited provider and am getting ready to rate. What do I need to do to receive the accreditation points and Area of Specialization?

You must indicate that your site is accredited on the Interactive Rating Readiness Tool (IRRT) and provide a current accreditation certificate for review by the data collector. DCYF will automatically add the accreditation points to your final rating score.

## I was accredited at the time of my last rating but am not currently accredited. Can I still receive the points?

Your program must have a current accreditation at the time of data collection to qualify for the accreditation points. If you choose to renew your accreditation, you will be eligible for these points during your next rating.

#### Are the five points applied to a specific area of evaluation?

No. These points are intended to serve as recognition of your hard work and commitment to quality through the accreditation process. They will be added to your program's overall points.

### I am an NAEYC-accredited provider that was just rated a Level 2. Why didn't I receive the accreditation points?

In order to qualify for the accreditation points, you must meet the designated minimum scores on CLASS and ERS. If you meet the minimum scores during a re-rate and have a current accreditation, you will receive the accreditation points at that time.

# I represent an accreditation agency that is not represented on DCYF's approved list. How can my agency become a recognized accrediting body?

An Application for Accrediting Agency Recognition is available to national accrediting bodies that have been in operation for a minimum of three years and oversee at least 100 accredited sites in multiple states, including Washington.
